USDA-accredited veterinarians can electronically issue health certificates and use VEHCS (Veterinary Export Health Certification System) to submit them to USDA for endorsement.

Digital endorsement varies by species—see requirements on this page for details. The health certificate either bears the original ink signature and embossed seal **or** digital signature/seal.

Animal Owners/Shippers: Digitally endorsed health certificates can be printed out directly from VEHCS. For non-digitally endorsed health certificates, you can arrange

Equine

Health Certificates for Horses to China must be digitally endorsed by APHIS within VEHCS and a printed copy accompany the shipment.

Note: **Although this health certificate is available as a fillable PDF file, it must be submitted to APHIS for endorsement via the Veterinary Export Health Certification System ([VEHCS](#)). This means a hard copy of the health certificate and required supporting documents (e.g. test results) cannot be submitted by mail or in person for review and finalization. [Click here for instructions on accessing VEHCS, and completing and submitting the health certificate and required supporting documents \(as a PDF\) to APHIS.](#) When submitting a PDF file through [VEHCS](#), it is preferred that the issuing Accredited Veterinarian sign the document using the ADOBE signature options, rather than printing, signing and scanning, for optimal quality resolution.

Cattle

(1) Only the below People's Republic of China (PRC) health certificates are approved for bovine semen and embryos from USA to PRC. When filing the health certificate form, please use the Tab key to move from field to field. **Do not use the Enter key.**

The below protocols and health certificates are only intended for US-resident cattle producing semen and/or in vivo embryos.

Please note, before bovine semen and embryos are eligible for export, the collection facilities must be inspected by Chinese officials.

Swine

As of **March 9, 2011**, China requires temporary attestation for novel A/H1N1 flu (additional document required). As of **August 1, 2014**, China requires negative PCR

test results for porcine epidemic diarrhea virus (PEDv) and porcine delta coronavirus (PDCoV) during quarantine (additional document required as of January 2022).

China **does not allow** live poultry exports from U.S. states they consider HPAI affected (as listed above).

Please modify **Certification Statement #1** of each of the following health certificates, to exclude all states currently banned, as follows:

1. **The United States of America officially confirms that commercial poultry flocks are free from highly pathogenic Avian Influenza (except for: *list all of the state above individually here*), viscerotropic velogenic Newcastle disease, and plague of gosling.**

APHIS Registered Aquaculture Export Facility [approval is required](#).

- **Health Certificate:** U.S. origin aquatic animals for **breeding and ornamental purposes** must use the [VS Form 17-141 "Health Certificate for the Export of Live Finfish, Mollusks, and Crustaceans \(and their Gametes\)"](#) (249.52 KB) for export purposes.
 - [Instructions for Completing the VS Form 17-141](#) (372.45 KB) (372.45 KB)
 - Note:** In section "I. Identification" only select the "Farmed/Aquaculture Stocks" option. The "Public resource/Wild/Feral Stocks" option should not be selected.
- **Facility Registration:** In addition to APHIS Registered Aquaculture Export Facility approval, U.S. origin **crustaceans** and **finfish** aquaculture facilities must be included on China's approval list before APHIS can endorse the export health certificate: [GACC's Quarantine Registration List of Overseas Animals and Plants and Relevant Products](#).

- **Note:** For the full list of U.S. facilities approved by GACC for these commodities, select the following: “United States of America” for the country/region, “Aquatic animals and genetic material” for the product type, and either “Ornamental aquatic animals” or “Breeding aquatic animals and genetic materials” for the product category. The “Overseas official registration No.” field in the table should match the APHIS Registered Aquaculture Export Facility approval number for a given facility.
- **Acceptable Species:** Only those U.S. origin aquatic animal **species** listed below have market access and are approved for export from the United States to China:

For exports of U.S. origin aquatic species that are not included on the lists above, the Chinese importer should contact the General Administration of Customs of the People’s Republic of China (GACC) to request a special import permit.

Research/Laboratory Animals

Health Certificates for Naked Mole Rats and Parasites & cocoons to China must be digitally endorsed by APHIS within VEHCS and a printed copy accompany the shipment.

Rodent health certificates must be printed, signed and physically endorsed by APHIS. All other commodities may be issued and endorsed within VEHCS.

Other Animals

Health Certificates for Giant Panda semen to China must be physically endorsed by APHIS with an original ink signature and embossed seal. The original APHIS-endorsed certificate must accompany the shipment.

If your species is not listed, the requirements for that species are not known. Exporters who want to ship livestock or germplasm whose requirements are not listed above should have the importer or buyer in the destination country apply for an import permit at the appropriate ministry. This import permit will most likely outline the specific requirements.

Tips for Exporters and Accredited Veterinarians

Endorsement Services

- **No in-person or drop-off services.**
- For fastest processing, have your [accredited veterinarian](#) **submit certificates through [VEHCS](#).**
- Routine APHIS VEHCS processing services are staffed Monday through Friday from 7:00 a.m. to 4:30 p.m. Central Time (CT), excluding Federal holidays. The time listed in VEHCS reflects GMT.
- Paper certificates are discouraged but may be mailed to one of our two paper endorsement offices (see addresses below).

Status Updates

Endorsement offices **cannot confirm delivery or provide status updates.** For updates:

- Contact your [accredited veterinarian](#) (they can check VEHCS status).
- Use your **mail tracking number.**

Important Tips

- Ensure accuracy and submit documents as early as possible within the allowed timeline of the destination country to avoid delays.
- Use **overnight or Saturday delivery** when mailing.
