Export Live Animals to Turkey

USDA-accredited veterinarians can electronically issue health certificates and use VEHCS (Veterinary Export Health Certification System) to submit them to USDA for endorsement.

USDA must ink-sign and emboss the health certificate.

What This Means for You

Animal Owners/Shippers: You can arrange to have your health certificate returned by mail (a prepaid, preaddressed return label must be provided during certificate submission). The endorsed health certificate—ink-signed and embossed—must accompany the animal(s) during shipment or travel.

Summary of Requirements

All health certificates for U.S.-origin animals and animal genetics destined to Turkey (with the exceptions of bovine semen and day-old poultry) must be endorsed by APHIS no more than 2 days before export. Exporters are advised to schedule health certificate endorsement with their [local APHIS endorsement office](#) accordingly.

The Ministry of Agriculture and Forestry (MinAF) of the Republic of Türkiye has shared the following list of entry ports in Türkiye that are permitted to inspect imported live animals and animal products. Please use this list of approved ports of entry when planning shipments of animals and germplasm.

Cattle

Effective **May 15, 2024**, the Ministry of Agriculture and Forestry (MinAF) of the Republic of Türkiye has temporarily suspended imports of bovine animals from the United States due to HPAI cases in mammals.

Bovine Semen

Effective **April 29, 2025**, an APHIS-endorsed, U.S.-origin **bovine semen** certificate is considered valid for **15 days** from the date of issuance by the USDA-accredited veterinarian, as noted on the updated health certificate (April 2025).

Sheep and Goats

Poultry

Due to highly pathogenic avian influenza (HPAI), the Ministry of Agriculture and Forestry of the Republic of Türkiye has imposed trade restrictions on U.S.-origin poultry, day-old chicks, and hatching eggs originating from or transiting through the following States:

- California
- Colorado
- Delaware
- Florida
- Georgia
- Idaho
- Illinois
- Indiana
- Iowa
- Kansas
- Maryland
- Minnesota
- Montana
- New Jersey
- North Carolina
- North Dakota
- Pennsylvania
- South Dakota
- Vermont
- Washington
- Wisconsin

Note: To apply for an import permit, a completed **sample** health certificate should be submitted to the Turkish import authorities. That certificate does not need to be signed by either the USDA accredited veterinarian, or the APHIS endorsing veterinarian. Once the import permit is issued, the USDA accredited veterinarian may proceed with issuing the **final** certificate, which must then be endorsed by APHIS.

Note: Day-old poultry certificates must be issued by the USDA-accredited veterinarian and endorsed by APHIS on page 6 within 10 days of departure. The USDA-accredited veterinarian must issue **Part III. Supplementary health information** addendum (page 7) no more than 2 days before export.

If your species is not listed, the requirements for that species are not known. Exporters who want to ship livestock or germplasm whose requirements are not listed above should have the importer or buyer in the destination country apply for an import permit at the appropriate ministry. This import permit will most likely outline the specific requirements.

Tips for Exporters and Accredited Veterinarians

Endorsement Services

- **No in-person or drop-off services.**
- For fastest processing, have your [accredited veterinarian](#) **submit certificates through [VEHCS](#).**
- Routine APHIS VEHCS processing services are staffed Monday through Friday from 7:00 a.m. to 4:30 p.m. Central Time (CT), excluding Federal holidays. The time listed in VEHCS reflects GMT.
- Paper certificates are discouraged but may be mailed to one of our two paper endorsement offices (see addresses below).

Status Updates

Endorsement offices **cannot confirm delivery or provide status updates.** For updates:

- Contact your [accredited veterinarian](#) (they can check VEHCS status).
- Use your **mail tracking number.**

Important Tips

- Ensure accuracy and submit documents as early as possible within the allowed timeline of the destination country to avoid delays.
- Use **overnight or Saturday delivery** when mailing.
