Details procedures that PPQ and State department of agriculture personnel can use to manage emerald ash borer infestations.

## **Golden Nematode Program Manual**

Provides instructions and procedures for PPQ and State regulatory officials to carry out detection and delimiting surveys, treat and certify regulated articles for movement from regulated areas, determine the movement status of regulated and nonregulated articles, and take regulatory action when golden nematode (*Globodera rostochiensis*) is detected.

## **Imported Fire Ant Program Manual**

Provides procedures for PPQ personnel and cooperators to carry out surveys, treat regulated articles for movement from regulated areas, and take regulatory action when imported fire ants are detected outside quarantined areas.

Provides procedures for PPQ personnel and cooperators to eradicate isolated khapra beetle infestations, prevent human-assisted spread of this pest, and detect low population infestations.

Provides procedures for PPQ and State department of agriculture inspectors to detect *Phytophthora ramorum* in nurseries that ship plants interstate.
