The National Veterinary Services Laboratories (NVSL) has laboratories in two locations: Ames, IA, and the Foreign Animal Disease Diagnostic Laboratory (FADDL) at Plum Island, NY. Diagnostic test services range from a single laboratory test to comprehensive laboratory services covering multiple pathogens for a suspected disease outbreak.
